Capillary penetration into inclined circular glass tubes

ABSTRACT

The spontaneous penetration of a wetting liquid into a vertical tube against the force of gravity and the imbibition of the same liquid into a horizontal tube (or channel) are both driven by capillary forces and described by the same fundamental equations. However, there have been few experimental studies of the transition from one orientation to the other. We report systematic measurements of capillary penetration of polydimethylsiloxane oils of viscosities 9.6, 19.2 and 48.0 mPas into glass capillary tubes. We first report the effect of tube radii R between 140 μm and 675 μm on the dynamics of spontaneous imbibition. We show that the data can be fitted using the exact numerical solution to the governing equations and that these are similar to fits using the analytical visco-gravitational approximation. However, larger diameter tubes show a rate of penetration slower than expected using an equilibrium contact angle and the known value of liquid viscosity. To account for the slowness, an increase in viscosity by a factor $(\eta/\rho)_{\text{scaling}}$ is needed. We show full agreement with theory requires the ratio $R/\kappa^{-1} \sim 0.1$ or less, where κ^{-1} is the capillary length. In addition, we propose an experimental method that enables the determination of the dynamic contact angle during imbibition, which gives values that agree with the literature values. We then report measurements of dynamic penetration into the tubes of $R=190 \mu\text{m}$ and $650 \mu\text{m}$ for a range of inclination angles to the horizontal, φ , from 5° to 90° . We show that capillary penetration can still be fitted using the visco-gravitational solution, rather than the Bosanquet solution which describes imbibition without gravity, even for inclination angles as low as 10° . Moreover, at these low angles, the effect of the tube radius is found to diminish and this appears to relate to an effective capillary length, $\kappa^{-1}(\varphi) = \sqrt{\gamma_{LV}/\rho g \sin \varphi}$.

14 15 16 17 **1. INTRODUCTION**

18
19 The flow of small amounts of liquid along microfluidic channels is generally governed by
20 capillarity-driven imbibition. Capillary imbibition has already been studied extensively in
21 printing, water infiltration in porous material, lab-on-chip and many other applications¹⁻⁵.
22
23 However, many previous investigations are based on theories focusing on two specific cases:
24 horizontally oriented capillaries, where gravity can be ignored, and vertically oriented capillaries,
25 where gravity has a major influence. The theory underlying these two cases, and the more
26 general case of a capillary oriented at an arbitrary angle, φ , to the horizontal, is described by a
27 differential equation, which involves inertial forces, viscous forces, hydrostatic pressure and the
28 capillary forces (see e.g. Ouali et al.⁶). Depending on the relative strength of these forces the rise,
29 or penetration length, of the liquid scales differently with time. There are a number of known
30 analytical solutions to approximations of the governing differential equation. These include the
31 early stage inertia dominated phase⁷, the late stage Lucas-Washburn viscous regime neglecting
32 gravity⁸⁻⁹, the more general Bosanquet solution which incorporates both of these solutions, but
33 neglects gravity¹⁰, and the visco-gravitational solution^{9,11}. The latter solution describes capillaries
34 in which the inertial force is neglected and the capillary force is balanced by the viscous force
35 and gravity and this regime is usually assumed to occur after the Lucas-Washburn regime¹²⁻¹⁵.

3 In liquids where the viscous forces are small (low viscosity liquids and wider tubes), the
4 capillary force is balanced by inertia and gravity, and imbibition is characterised by the inertial
5 regime at the very early stages, followed by a viscosity damped oscillatory regime about the
6 equilibrium height, which completely replaces the Lucas-Washburn regime¹⁶⁻¹⁹. Recently, Das
7 and Mitra¹⁸ found that the different regimes of capillary rise in vertical capillaries are determined
8 by the ratio of the Ohnesorge number (Oh) to the Bond number (Bo). The limit $Oh/Bo \gg 1$
9 corresponds to a monotonic rise dominated by the Lucas-Washburn regime, followed by
10 gravitational effects at the end of the rise. $Oh/Bo \ll 1$ corresponds to the case when the rise is
11 characterised by the damped oscillatory behaviour and there is no Lucas-Washburn regime.
12 When $Oh/Bo \sim 1$, an intermediate regime is observed. In recent work, we developed a numerical
13 procedure for fitting experimental data to the exact differential equation in which the viscous
14 force dominates inertia and reported analytical expressions for the transition between the
15 Bosanquet and visco-gravitational solutions⁶. In that work our experimental focus was on
16 capillary rise in channels of rectangular cross section where one side of the channel was open to
17 air; this was motivated by an interest in how the process of capillary rise crosses over into
18 microfluidics with open and closed channels.

41 An interesting issue for capillary driven imbibition into near horizontal microfluidic channels
42 is the extent to which gravity can be neglected. In this work we report a systematic investigation
43 into capillary driven penetration of polydimethylsiloxane (PDMS) oils into circular cross-section
44 glass tubes at angles of orientation from the vertical to near horizontal (around 5° from the
45 horizontal). Our experimental work covers a range from one clearly described by a visco-
46 gravitational solution to a near horizontal tube where it might be expected a Bosanquet equation
47 would be the most appropriate description. In section 2, we first provide a summary of the

3 theory, including the governing differential equation, and the visco-gravitational and Bosanquet
4 solution, in a form that includes the effects on gravitational forces from the angle of inclination
5 to the horizontal, φ . We also summarize numerical results detailing the cross-over from the
6 Bosanquet to the visco-gravitational solution as the most accurate approximation to the
7 governing differential equation. In sections 3 and 4, we consider the effect of tube diameter on
8 the fitting of capillary rise in vertically oriented tubes.

11 In our previous work, we noted that although fits to the exact equations were possible using an
12 effective viscosity, numerical agreement with known values of viscosity only occurred for small
13 diameter tubes. This was probably due to the effective viscosity compensating for the use of a
14 fixed value of contact angle rather than including a time dependent early stage dynamic contact
15 angle^{20,6}. Here, we conclude that this effect is controlled by $R/\kappa^1(\varphi)$, where $\kappa^1(\varphi)$ is the capillary
16 length taking into account the reduction in gravitational force due to the angle of inclination, and
17 becomes less of an issue as a tube approaches the horizontal orientation. Our results of capillary
18 penetration into tilted tubes also inform understanding of the transition from a vertical
19 orientation towards a horizontal orientation thereby investigating a progressively decreasing
20 influence of gravity. We find that even for very low angles of 10° the PDMS oils we investigated
21 obey a visco-gravitational solution. We also report a new experimental method that enable the
22 determination of the velocity dependent dynamic contact angle that gives values in agreement
23 with the literature.

48 **2. THEORETICAL APPROACH**

49
50 The theory of capillary-driven imbibition of a liquid of viscosity, η , and density, ρ , into a
51 circular cross-section tube of radius R , at an arbitrary angle to the horizontal, φ , results in a

governing equation for the penetration length along the tilted tube, $x(t)$, as a function of time, t , of,

$$\frac{1}{2} \frac{d}{dt} \left(\frac{dx^2}{dt} \right) = b - g \sin \varphi x - ax \left(\frac{dx}{dt} \right) \quad (1)$$

where $g=9.81 \text{ m s}^{-2}$ is the acceleration due to gravity. In this form of the equation, the viscous coefficient a has dimensions of inverse time (s^{-1}) and the capillary coefficient term b has dimensions of $(\text{speed})^2$ (m^2s^{-2}), and are given by,

$$a = 8\eta/\rho R^2 \quad \text{and} \quad b(t) = 2\gamma_{LV} \cos\theta(t)/\rho R \quad (2)$$

The force driving the imbibition (or rise) is capillarity and the forces resisting the imbibition are gravity and viscous forces. If a velocity dependent, and hence time dependent, dynamic contact angle, $\theta=\theta(t)$, is assumed a further defining equation relating the dynamic contact angle to the instantaneous speed and physical parameters is required^{14,20-22}. However, it is often assumed that the contact angle can be approximated to a constant $\theta=\theta_A$ (the advancing contact angle) and with this assumption eq. (1) can be fitted numerically to a set of experimental data⁶. There are also several approximations to eq. (1) with $\theta=\theta_A$ that allow analytical solutions in the cases where gravity is dominant or where gravity can be neglected; for a recent summary see Ouali et al⁶.

When $g\sin\varphi \rightarrow 0$ so that the capillary is horizontally oriented, the solution to eq. (1) is the Bosanquet solution¹⁰,

$$x^2(t) = \left(\frac{2b}{a^2} \right) \{ at - [1 - \exp(- at)] \} \quad (3)$$

This solution includes the long time limit solution $x(t)=(2b/a)^{1/2}t^{1/2}$, which is the Lucas-Washburn solution when the viscous term dominates, and also the short time limit solution,

3 $x(t)=b^{1/2}t$, which is the inertial solution of Quéré⁷. As shown by Washburn⁹, and discussed by
4
5 Fries and Dreyer^{11,17,24} (see also Mumley et al.,¹² and Krotov and Rusanov¹³), eq. (1) also has a

7 visco-gravitational solution,

15 where the inertial term has been ignored; a constant contact angle and $x=0$ at $t=0$ have also
16
17 been assumed in deriving this solution. The equilibrium penetration length is given by,

$$20 \quad x_e = \frac{b}{g \sin \varphi} \quad (5)$$

24 The fact eq. (4) is an analytical solution with time as a function of position, which cannot be
25
26 easily inverted, does not prevent fitting of experimental data since time can be fitted as a
27
28 function of measured position as easily as position as a function of measured time. Interestingly,
29
30 the extreme long time limit of eq. (4) is an exponential approach to equilibrium, $x/x_e \rightarrow (1 - \exp(-$
31
32 $t/\tau))$ with a time constant $\tau = ab/(g \sin \varphi)^2$. The short time limit with $x/x_e \ll 1$ is the Lucas-
33
34 Washburn solution $x(t)^2 = (2b/a)t$, so that the short time limit of the visco-gravitational solution
35
36 corresponds to the long-time limit of the Bosanquet equation; these solutions should therefore
37
38 have a cross-over.

42 43 **2.1. Identifying regimes of approximation**

44
45 It is useful to separate an experimental data series into a form where each range of
46
47 approximation from inertial to Lucas-Washburn to visco-gravitational can be easily identified.
48
49 Motivated by the series expansion of the logarithmic term in the visco-gravitational solution, we
50
51 consider the dependence of t/x^2 as a function of x . In this form, the small time limit (inertial
52
53 approximation) of the Bosanquet solution eq. (3) is,

$$\frac{t}{x^2} \approx \frac{1}{\sqrt{b} x} = \frac{1}{\sqrt{x_e g \sin \varphi} x} \quad (6)$$

As time increases this inertial solution crosses over to the Bosanquet solution (eq. (3)), which in the long time limit (Lucas-Washburn) approximation is dominated by the linear term in t and so gives,

$$\frac{t}{x^2} \rightarrow \frac{a}{2b} \quad (7)$$

Equation (7) also matches the small time approximation of the visco-gravitational solution,

$$\frac{t}{x^2} \rightarrow \left(\frac{a}{2b} \right) \left[1 + \frac{2}{3} \left(\frac{x}{x_e} \right) + \frac{1}{2} \left(\frac{x}{x_e} \right)^2 + \dots \right] \quad (8)$$

At much longer times t/x^2 logarithmically diverges as a function of x because x approaches x_e exponentially.

The changeover of behaviour from a $1/x$ to a constant of $a/2b$ to a divergence should be visually distinctive and enable the appropriate fitting equation (eq. (3) or eq. (4) or the inertial or Lucas-Washburn approximations) to be used. The inertial to Lucas-Washburn transition occurs when x satisfies both eq. (6) and eq. (7), i.e.

$$x_{I \rightarrow LW} \sim \frac{2\sqrt{b}}{a} \propto \frac{\sqrt{R^3}}{\eta} \quad (9)$$

which is equivalent to $t_{I \rightarrow LW} = 2/a$, so $x_{I \rightarrow LW}$ increases with R . The Lucas-Washburn to visco-gravitational transition occurs when the first order correction in eq. (8) becomes non-negligible, $2x/3x_e \sim 0.1$, i.e.

$$x_{LW \rightarrow VG} \sim 0.15x_e \quad (10)$$

2.2. Cross-over between Bosanquet and visco-gravitational solutions

Numerically the initial penetration length is best described by the Bosanquet solution (eq. (3)) until it crosses over with the visco-gravitational solution (eq. (4)). Above this cross-over the visco-gravitational solution ever more closely agrees with the exact numerical solution as the capillary penetration length tends to its equilibrium value; however, it always lies above the exact numerical solution. The cross-over time, t_c , can be calculated numerically as a function of $g\sin\varphi$. as shown in Ouali⁶, and this gives,

$$t_c \approx \frac{1}{f(at_c)} \left(\frac{9x_e^2}{8ab} \right)^{1/3} \quad (11)$$

where

$$f(at_c) = \frac{1 - (1 - \exp(-at_c))/(at_c)}{(1 - \exp(-at_c))^{2/3}} \quad (12)$$

In the limit of large at_c the function $f(at_c) \rightarrow 1$, and hence eq. (11), gives the cross-over time as a $2/3^{\text{rd}}$ power law in the equilibrium penetration length, i.e. $t_c \propto x_e^{2/3}$. The cross-over length, x_c , as a fraction of the equilibrium length, x_e , can be written using the equilibrium length⁶,

$$\frac{x_c}{x_e} \approx \left(\frac{3b}{a^2 x_e^2} \right)^{1/3} \quad (13)$$

2.3. Non-dimensional analysis of the different regimes

To identify the different regimes, the relationship between t/x^2 and x can be used, and in order to generalize the obtained solutions the data can be plotted in a non-dimensional form as T/X^2 against $X=x/x_e$, where $T=t/\tau$ and τ is a characteristic time motivated by the visco-gravitational solution (eq. (4)) and defined as

$$\tau = (a b / g^2 \sin^2 \varphi) = a x_e / g \sin \varphi \quad (14)$$

In this form, the first of the limiting regimes, in increasing value of x , is the inertial regime, which from eq. (6) is,

$$\left(\frac{T}{X^2}\right)_I = \frac{tx_e^2}{\alpha^2} = \frac{1}{2} \left\{ 1 - \frac{1}{a\tau T} (1 - \exp(-a\tau T)) \right\}^{-1} \approx \left(\frac{1}{\sqrt{a\tau}}\right) \frac{1}{X} \quad (15)$$

This crosses over into the Bosanquet solution (eq. (3)). The second regime, the Lucas-Washburn solution, is given from eq. (7) as,

$$\left(\frac{T}{X^2}\right)_{LW} = \frac{tx_e^2}{\alpha^2} = \frac{1}{2} \quad (16)$$

and the third regime, the visco-gravitational solution, is given from eq. (4) as,

$$\left(\frac{T}{X^2}\right)_{VG} = \frac{tx_e^2}{\alpha^2} = -\left(\frac{1}{X}\right) \left[1 + \left(\frac{1}{X}\right) \ln(1-X) \right] \quad (17)$$

In this form, the cross-over, $X_c = x_c/x_e$, from Bosanquet to visco-gravitational is given from eq. (13) by,

$$X_c = \left(\frac{3}{a\tau}\right)^{1/3} \quad (18)$$

and the defining differential equation is,

$$\frac{1}{2a\tau} \frac{d}{dT} \left(\frac{dX^2}{dT} \right) = 1 - X - X \left(\frac{dX}{dT} \right) \quad (19)$$

From eq. (9) and eq. (18), the cross-over from the inertial to Lucas-Washburn regime would be expected at,

$$X_{I \rightarrow LW} = \frac{x_{I \rightarrow LW}}{x_e} \sim \frac{2}{\sqrt{a\tau}} = \frac{2X_c^{3/2}}{\sqrt{3}} \quad (20)$$

$X_{I \rightarrow LW} < X_c$ for $X_c < 0.75$. This was found to be the case in all our experiments.

3. EXPERIMENTAL METHODS

To observe experimentally the effect of a diminishing influence of gravity, an experimental set-up was developed to allow the monitoring of capillary penetration into a tilted circular cross-section tube (fig. 1). Due to difficulties in liquid penetration at the entry to almost horizontal tubes, the angular range used was 5° to 90° , where 90° gives a vertically mounted tube. Data for penetration length and time taken for tubes at different tilt angles for tubes can then be numerically fitted by eq. (1) and compared to fits to the analytical solutions for the two regimes of zero gravity (Bosanquet solution, eq. (3)) or the visco-gravitational regime (eq. (4)). The effectiveness of the fits can then be compared to the expected form based on the cross-over time.

One difficulty with this approach, as described in our previous work⁶, is that although the numerical fitting of eq. (1) to experimental data is possible using a constant contact angle, it necessarily requires the a parameter to be numerically adjusted (*via* an effective viscosity significantly larger than known value) to obtain fits that agree with the experimental data. This was interpreted as due to a dynamic contact angle that was much larger during the initial stages of capillary rise, thus reducing the initial capillary pull compared to expectations based on a quasi-static equilibrium contact angle. A large effective viscosity then compensates for the constant contact angle assumption since it reduces the rate of imbibition in the earlier stages of capillary rise. The validity of this interpretation will be discussed in section 4.3.

To look at the need for an effective viscosity, prior to taking systematic data for tilt angles, we considered the effect of tube diameter on the extent to which capillary rise and penetration data can be fitted by eq. (1) with known values of viscosity. Capillary rise of polydimethylsiloxane (PDMS) oil (Dow Corning, Xiameter PMX-200) of viscosity $\eta=9.6, 19.2$ and 48.0 mPas ($\pm 5\%$) at 25° , with corresponding densities of $\rho=913, 930$ and 950 kg m⁻³ and surface tension $\gamma_{LV}=19.8$

3 mN m⁻¹, into vertically oriented tubes of radius 140μm, 185μm, 295μm, 430μm, 525μm, 575μm
4
5 and 675μm (±5 μm) were examined. This range was chosen because the capillary length is κ^{-1}

7 $l_c = (\gamma_{LV}/\rho g)^{1/2} = (1.47 \pm 0.02)$ mm and this gives a tube radius to capillary radius range of $R/\kappa^{-1} \approx 0.1$

13 Fig. 1 shows the experimental set up. The PDMS oil reservoir was raised into contact with the
14
15 capillary tube. Recording was made *via* a CCD camera (up to 60 frames per second) and the
16
17 evolution of the meniscus penetration length along the tube, x , recorded as a function of time, t ;
18
19 reference graticules were used alongside each tube for calibration of length (fig. 1). Using our
20
21 image analysis approach led to large data sets for each individual experiment and so data points
22
23 presented in the results section are representative ones from reduced data sets. Experiments at
24
25 each viscosity and for each tube were repeated five times to establish reproducibility of the data.
26
27 The ambient temperature was recorded and the value was stable for a given experiment and
28
29 varied in the range 23-26 °C between experiments. The variation in viscosity from the
30
31 temperature variation was confirmed using rheology measurements to be less than 5% of the
32
33 values at 25° C.

40 In the experiments using tilted tubes, two radii of 190μm and 650μm were considered with the
41
42 tube orientation systematically changed in steps of 10° from a completely vertical orientation to
43
44 10° from the horizontal; a final set of capillary imbibition measurements at an angle of
45
46 inclination of 5° from the horizontal was also used. In these experiments the CCD camera was
47
48 also orientated at the same angle so that the tube remained aligned vertical in the field of view
49
50 thereby enabling the measurement of the oil penetration length along the titled tube. Video
51
52 capture commenced before the reservoir was brought into contact with the tube and continued
53
54 until either the liquid achieved an equilibrium length or, for shallow title angles of the thinner
55

3 tube, had reached the maximum field of view. For the majority of cases, the full penetration to an
4
5 equilibrium length along the tilted tube could be observed. In all cases, the fitting of eq. (1) to the
6
7 data was possible. After each experiment the video of liquid penetrating into the tube was loaded
8
9 into image processing software, the calibration factor for length determined, a zero time assigned
10
11 to the frame immediately before the liquid started to penetrate the tube, the final frame subtracted
12
13 from all preceding frames and a threshold image processing operation performed. These videos
14
15 were then loaded into MATLAB[®] (Mathworks) and the position of the meniscus in every frame
16
17 was calculated as a function of time.
18

22 The variation of capillary rise with time (penetration length in tilted tubes) data were fitted to
23
24 the governing differential equation, eq. (1), and to the visco-gravitational solution, eq. (4), using
25
26 Mathematica[®] with a and b as free fitting parameters. We also numerically determined the
27
28 solution to eq. (1) using i) the theoretical value of a (determined by the literature reference value
29
30 of viscosity) and a b value scaled to match the observed rise (equivalent to scaling the surface
31
32 tension/density) and ii) the values of parameters from the fitting to the visco-gravitational
33
34 solution, to visually verify the extent to which the solutions were in agreement.

39 **4. RESULTS AND DISCUSSIONS**

40 **4.1. Vertical rise and effect of tube diameter**

41
42 We observed that the plot of capillary rise with time followed the expected shape from the
43
44 numerical solution to the governing differential equation (eq. (1)), or equivalently the visco-
45
46 gravitational solution (eq. (4)). The equilibrium length tended to be slightly different to that
47
48 predicted using the literature reference parameter values, but this could be corrected by using a
49
50 scaling factor (~ 1) for b (or equivalently $(\gamma_{LV}/\rho)_{scaling}$). However, as previously reported⁶, for
51
52 large radii tubes the data appeared to follow curves with much higher viscosity (or more
53

4 correctly higher (η/ρ) or equivalently higher values of a , and, in agreement with other reports in
5
6 the literature^{18,25}. An example of this is given by the dashed line in the inset to fig. 2 ($R=430\ \mu\text{m}$,

8 $\eta=9.6\ \text{mPas}$, $\rho=913\ \text{kg m}^{-3}$ and $\gamma_{LV}=19.8\ \text{mN m}^{-1}$ with $(\gamma_{LV}/\rho)_{scaling}=0.9651$ to match the
9
10 equilibrium length).

11

13 To fit the experimental data, an increase in effective viscosity of $a_{scaling}=(\eta/\rho)_{scaling}=2.628$ is
14
15 required. In this case, and all other viscosities and radii examined for vertical tubes, the visco-
16
17 gravitational solution could be fitted to the data. Moreover, using the same parameters gave a
18
19 numerical solution to eq. (1) which on a penetration length-time plot was indistinguishable to the
20
21 visco-gravitational solution. We observed that the scaling factor required to fit the data, reduced
22
23 towards unity as tubes of smaller radii were used. The main part of fig. 2 summarizes the scaling
24
25 factors $a_{scaling}=(\eta/\rho)_{scaling}$ as a function of the ratio of tube radius to capillary length, R/κ^{-1} .
26
27 Scaling factors required to fit the data for capillary rise of PDMS oils of viscosities 9.6 mPas
28
29 ($\diamond\diamond\diamond$), 19.2 mPas ($\circ\circ\circ$) and 48.0 mPas ($\Delta\Delta\Delta$) inside glass. The data and theory come into
30
31 agreement when $R/\kappa^{-1}<0.1$. The dashed lines are to guide the eye for the trend with the ratio of
32
33 radius to capillary length. It is notable that the curves in fig. 2 do not follow a steadily increasing
34
35 or decreasing trend with viscosity and do not scale with viscosity in a simple manner.

36
37
38 We observed visually that as the PDMS penetrates into a tube the contact angle appears to
39
40 evolve from a high angle value towards 0° . In the first frames, the meniscus is flat but then
41
42 shapes itself toward a spherical form as the liquid rises into the tube. When the equilibrium is
43
44 reached, the observed contact angle is close to zero degrees. This appears to confirm the
45
46 interpretation of Ouali⁶ and others^{14,25,26} that eq. (4) using a constant value of $\theta=0^\circ$ is incorrect
47
48 and this is found to have a measurable effect on the rate of imbibition in the early stage of
49
50 penetration as discussed in section 4.3. Figure 2 confirms that this effect systematically reduces
51

3 for thin capillary tubes, $R \ll \kappa^{-1}$, in which the surface area to volume ratio increases as the tube
4 radius decreases. Recently, Das and Mitra¹⁸ attributed the increase of the scaling factor to a non-
5 parabolic fluid velocity profile, characterized by a steeper velocity gradient of the liquid near the
6 wall of the tube compared to the bulk, giving rise to an increased viscous force (hence of a). The
7 difference between gradients near the wall and bulk reduces as the radii of the channels
8 decreases, thus, improving agreement with theory in thinner tubes. This interpretation may be
9 consistent with a dependence of the effective viscosity on the ratio R/κ^{-1} . However, irrespective
10 of the physical reason it appears experimentally that this is a key parameter combination
11 determining whether an effective viscosity is required when assuming a constant contact angle.

24 **4.2. Vertical rise and different regimes**

25
26
27 Figs. 3a and 3b show the rise dynamics of PDMS oil in the form of a semi-log plot of $X=x/x_e$
28 as a function of time, for three data sets in the smallest vertical tube ($R=140 \mu\text{m}$) at $\eta=19.2 \text{ mPas}$
29 and the widest ($R=675 \mu\text{m}$) at $\eta=9.6 \text{ mPas}$ as respectively. In each graph, the corresponding
30 Bosanquet and visco-gravitational fits are shown as a solid and dashed lines respectively, and the
31 vertical dotted lines show cross-over penetration lengths X_{LW} and X_c . The graphs show that the
32 visco-gravitational solution is the best analytical fit to the rise for most of the range.
33

42 To analyze the data for capillary rise, the rise versus time to the equilibrium length, x_e of the
43 three data set (eg. figs 3a and 3b) were used as the starting points to plot the data sets using
44 $T/X^2 = (t/\tau) \times x_e^2/x^2$ against X to overlay the data as $X \rightarrow 1$ where the characteristic time, τ , (eq. (14))
45 is a fitting parameter. Examples of the results are shown in fig. 3c and 3d. In the early stages of
46 capillary rise, there is a small offset in time due to the frame rate used, for the data moves the
47 value of T/X^2 , but the data points tend to lie on a similar curve. However, the associated errors
48

3 due to the frame rate seem to have a sizeable effect at the very early stages. In the final part of
4 the capillary rise the fit to the data is very sensitive to choice of the τ parameter.
5

8 In the smallest radius ($R=140\ \mu\text{m}$) vertical tubes at $\eta=19.2\ \text{mPas}$ (fig 3c), we found the x_e
9 value on one data set needed to be adjusted by 0.5%. A value of $\tau=29\ \text{s}$ was chosen to fit the
10 visco-gravitational solution (eq. (16) (dashed line); this also determined the Lucas-Washburn
11 solution, eq. (16) (horizontal dashed line). Finally, a value of $a = \tau g \sin\phi / x_e = 9680\ \text{s}^{-1}$ ($\phi=90^\circ$) (eq.
12 (14)) was used for the Bosanquet solution (eq. (3) or eq. (15). The values of a and τ then give the
13 Bosanquet to visco-gravitational cross-over, $X_c = 0.022$ (eq. (18)) and the cross-over penetration
14 length $X_{I-LW}=0.004$ (eq. (20) (also shown as the vertical dotted lines in fig. 3b). It is of note that
15 the value of $a=9680\ \text{s}^{-1}$ obtained from this method agrees well with the corresponding average
16 value $a=9652\ \text{s}^{-1}$ (SD $178\ \text{s}^{-1}$) obtained from the analytical and numerical fits of penetration
17 versus time data in fig 3a.

32 The widest tube (fig. 3d), corresponding to $R=675\ \mu\text{m}$ and $\eta=9.6\ \text{mPas}$, gives a theoretical
33 value of $X_c=0.509$, thus $X_{I \rightarrow LW}=0.419$, but this is larger than the cross over from Lucas-Washburn
34 to visco-gravitational regimes expected at $X_{LW \rightarrow VG} \sim 0.15$. Thus the Lucas-Washburn regime
35 should not occur for this data set. So at no time could the Bosanquet solution be regarded in the
36 long time limit and nor can the visco-gravitational solution be regarded in the short time limit.
37 However, since capillary penetration is observed to be slower than theoretically predicted (fig.
38 2), using the larger fitted value for the effective viscosity in eq. (18) would give a smaller
39 effective value $X_{I \rightarrow LW}=0.074$ and a corresponding $X_c = 0.160$ which is close to $X_{LW \rightarrow VG} \sim 0.150$ as
40 shown by the vertical dotted lines in fig. 3d (and the horizontal line in fig. 3b). This suggests, for
41 these tubes, a regime where the transition to the Lucas-Washburn regime occurs just as gravity
42

3 starts to play a role. However, the visco-gravitational solution should still be the best fit to the
4
5 data for most of the range ($X > X_c = 0.16$) as is clearly shown in fig. 3b.

8 We note that, there is a kink at intermediate stages in the region of $x/x_e \sim 0.8$ in fig. 3d. $Oh/Bo =$
9
10 $\frac{\eta}{g} \sqrt{\frac{\gamma_{LV}}{\rho^3 R^5}} \sim 2$ for these tubes, which may suggest a behavior that is intermediate between
11
12 oscillatory and viscous driven flow as proposed by Das and Mitra¹⁸ or a transition to the
13
14 oscillatory regime in these wide tubes for $\eta = 9.6$ mPas. Further investigations would be required
15
16 to verify this. Furthermore, we note that a similar transitional behavior was also observed in
17
18 vertical tubes of radii $R = 525 \mu\text{m}$ and $575 \mu\text{m}$ for $\eta = 9.6$ mPas, but that the Lucas-Washburn
19
20 regime was found to occur in the smaller tubes ($R = 140 \mu\text{m}$, $185 \mu\text{m}$, $295 \mu\text{m}$ and $430 \mu\text{m}$) for
21
22 $\eta = 9.6$ mPas and in all vertical tubes (including $R = 675 \mu\text{m}$) for $\eta = 19.2$ mPas and 48.0 mPas.

30 The data in figs. 3c and 3d deviate from the visco-gravitational solution in the early to
31
32 intermediate stages and implies that the data never reaches a situation when the Lucas-Washburn
33
34 regime actually applies even though the flow is viscous driven. A similar behavior was observed
35
36 in all other tubes and viscosities and could not be accounted for in terms of experimental errors,
37
38 such as those associated with the frame rate. A possible reason for this systematic deviation will
39
40 be discussed next.
41
42

43 **4.3. The effect of a dynamic contact angle**

44
45 The above analysis assumes a constant static contact angle value $\theta = 0^\circ$, which is not consistent
46
47 with the experimental observations at the very early stages of rise and with other work in the
48
49 literature^{14,25,26}. Next, we attempt to account for the deviation of the data from the visco-
50
51 gravitational solution in the early to intermediate stages in figs. 3c and 3d in terms of a velocity
52
53 dependent dynamic contact angle $\theta(t)$.

3 Since accurate measurements of the $\theta(t)$ were not possible in this work, we have estimated
4 $\theta(t)$ by fitting Hoffman's empirical measurements of the variation of $\theta(t)$ with capillary number
5 $Ca=V\eta/\gamma_{LV}$ (where V is the liquid front velocity) in the region $10^{-5}\leq Ca\leq 10^{-2}$ obtained for silicone
6 oils in glass tubes²² and used by many authors (e.g. Katoh et al.²⁶). We find that the dynamic
7 contact angle can be expressed as $\theta(t)=\theta+228\times Ca^{0.3287}$, where $\theta(t)$ and θ are in degrees (referred
8 to hereafter as the Hoffman correlation). We note that there are alternative numerical correlations
9 that could be used for $\theta(t)$ (see, e.g., Bracke et al.²³, Fries & Dreyer²⁴, Chebbi²⁸). Figs 4a and 4b
10 show the values of $\theta(t)$ for the data of fig 3a and 3b respectively estimated using the above
11 Hoffman correlation.

26 Given that x_e and τ (eq. 14) are both proportional to b , and, if we now consider that the contact
27 angle is $\theta(t)$, then $b(t)\propto\cos\theta(t)$, so the vertical axis $T/X^2 = (t/x^2)\times(x_e^2/\tau)\propto b(t)\propto\cos\theta(t)$. So, for
28 each experimental data point in figs. 3c and 3d, using the static angle value θ overestimates the
29 scaling factor of T/X^2 by a factor $\cos\theta/\cos\theta(t)=1/\cos\theta(t)$ (as $\theta=0^\circ$) compared to the visco-
30 gravitational solution which uses a constant value θ . So, in order to be able to compare the scaled
31 experimental data T/X^2 in figs. 3c and 3d to the visco-gravitational solution, T/X^2 must be
32 multiplied by the corresponding $\cos\theta(t)$ ($\theta(t)$ from figs. 4a and 4b). Figs. 4c and 4d show that a
33 much improved agreement with the visco-gravitational solution (eq. (17)), including at the very
34 early stages of rise, is obtained as a result.

49 Similar results were observed for all other tube radii and viscosities indicating that a dynamic
50 contact angle needs be taken into account in any quantitative analysis at the early stages of
51 imbibition in agreement with other work in the literature²². It is of note, however, that the use of
52 the dynamic contact angle only slightly affects the fitted value of τ , hence a , by $\leq 5\%$. This
53

3 indicates that: a) it cannot account solely for the increase in the scaled viscosity with radius as
4 we proposed previously⁶, and b) that use of a static angle in the numerical and analytical fits
5 should still be adequate to describe imbibition. However, the method above is solely
6 experimental and does not attempt to include the effects of $\theta(t)$ in the governing equations or in
7 the numerical fits.

14 **4.4. A new method for estimating the dynamic contact angle**

15
16 The results of figs. 4c and 4d also indicate that it may be possible to estimate the dynamic
17 contact angle from the penetration length along the tube-time data for any given tube in viscous
18 dominated flow by the following new procedure: i) fit the penetration length vs time data either
19 using the visco-gravitational solution or numerical solution to determine a and x_e , ii) rescale the
20 data to obtain $T/X^2 = ((t/x^2) \times x_e^2 / \tau)_{\text{scaled}}$ where τ is calculated from the fitted values using eq. (14),
21 and iii) for each experimental point $X=x/x_e$, $\theta(t)$ can be estimated from
22

$\cos \theta(t) = \left(\frac{T}{X^2} \right)_{VG} / \left(\frac{T}{X^2} \right)$, where $\left(\frac{T}{X^2} \right)_{VG}$ is given by eq. (17). Figure 5 shows the obtained estimates of $\theta(t)$, shown as filled-in circles, using this method for $R=140 \mu\text{m}$ and $\eta=19.2 \text{ mPas}$ (data of fig. 3c). Also shown are the values of contact angle, shown as unfilled squares, obtained using the Hoffman correlation (fig. 4a). As anticipated, an excellent agreement is observed between the two independent methods of estimating $\theta(t)$ for the data used. Similar results were obtained for other tubes and viscosities.

In addition, the values of $\theta(t)$ estimated using the method above agree very well with the recently proposed empirical trend which relates x/x_e , and experimentally measured $\theta(t)$ for

vertical and tilted geometries as $\frac{x}{x_e} = A \exp\left(\frac{-(\theta(t) - B)^2}{2C^2}\right)^{1/4R}$ (Heshmati and Piri²⁵), where R is

3 the radius of the tube in mm, as shown by the solid line in fig. 5. The solid line uses the same
4 values of $A=1.03$, $B= -2.47$ and $C=27.7$ as Heshmati and Piri. We found that the Heshmati and
5 Piri formula fits data for all tubes and inclinations, although a slightly lower value for C was
6 sometimes needed for better fits. This agreement gives us confidence in our proposed
7 methodology of estimating $\theta(t)$.
8

10 11 12 13 14 15 **4.5. Different regimes of flow in tilted tubes**

16
17
18 Fig. 6 shows the effect of tilt angle φ ($5 \leq \varphi \leq 90^\circ$) on the fitted equilibrium penetration length
19 x_e for tubes of radii 650 μm and 190 μm . The dashed lines show the corresponding theoretical
20 predictions for x_e . A good agreement with predictions is obtained (to within 5%) apart from the
21 shallowest tubes ($\varphi=5$ and 10°) where differences of up to 15% were observed between fitted
22 values and theory in the thin tube. These larger differences are attributed to the difficulty in
23 observing the meniscus at the very early stages in these almost horizontal tubes because of the
24 external meniscus covering the tube and because of larger uncertainties in determining the value
25 of x_e where penetration lengths are beyond the maximum field of view of the camera.

Capillary penetration for different φ were also fitted using the Bosanquet, numerical and visco-gravitational solutions in tubes of radii 190 μm and 650 μm assuming a constant advancing contact angle $\theta= 0^\circ$. Figs 7a and 7b show the penetration dynamics for oil viscosity 9.6 mPas in tubes of radii 650 μm and 190 μm respectively and the dashed curves show the corresponding visco-gravitational fits. Here again the visco-gravitational was found to be adequate to fit the data.

We next discuss the different regimes of flow in tilted tubes and the role of gravity. $X_c \sim (3b/a^2 x_e^2)^{1/3}$ (eq. (13)) and $X_{I \rightarrow LW} \sim 2X_c^{3/2}/\sqrt{3}$ (eq. (20), so can be expressed in terms of

4 R and φ as $X_c \sim \left(R^5 g^2 \sin^2 \varphi / \eta^2 \right)^{1/3}$ and $X_{I \rightarrow LW} \propto \left(R^5 g^2 \sin^2 \varphi / \eta^2 \right)^{1/2}$. The largest possible
5
6
7
8 value X_c is, thus, for the most vertical ($\varphi = 90^\circ$) and widest tubes ($R = 650 \mu\text{m}$) at $\eta = 9.6 \text{ mPas}$ for
9
10 which an effective value of $X_c = 0.123$ was needed to fit the data, and X_c decreases to 0.077 and
11
12 0.048 for $\eta = 19.2 \text{ mPas}$ and 48.0 mPas respectively. Moreover, for a given tube radius R and
13
14 viscosity, X_c should decrease with decreasing φ , hence with decreasing gravitational force,
15
16 although we note that the corresponding penetration length values $x_c \propto \left(R^2 / g \sin \varphi \eta^2 \right)^{1/3}$ and
17
18 $x_e \propto 1 / (Rg \sin \varphi)$ both increase with decreasing φ . Our analysis found the effective values of X_c
19
20 to decrease with decreasing φ , but more slowly than predicted theoretically. We attribute this
21
22 slower decrease to the dependence of the effective viscosity on φ discussed below in section 4.5.
23

30 In addition, we found that for both $R = 650 \mu\text{m}$ and $R = 190 \mu\text{m}$, for any given viscosity and tilt
31
32 angles, liquid imbibition is best fitted by the visco-gravitational, rather than the Bosanquet
33
34 solution, for most of the range, even for angles as low as 10° as shown in fig. 8. A value
35
36 $X_c = 0.031$ ($x_c = 1.32 \text{ mm}$, $x_e = 42.00 \text{ mm}$) was obtained for $R = 650 \mu\text{m}$ and $\eta = 48.0 \text{ mPas}$ at
37
38 $\varphi = 10^\circ$. This indicates that gravity needs to be taken into account (for $X > X_c$) even in these near
39
40 horizontal tubes and that ignoring gravity, as is often the case in microfluidic devices²⁷,
41
42 theoretically overestimates the rate of imbibition. This is particularly important in narrow
43
44 capillaries and micro-sized channels since X_c reduces with R ($X_c \propto R^{5/3}$) which may have
45
46 implications in understanding the flow dynamics, design and operation of microfluidic systems
47
48 based on capillary filling and flow control^{5,29}. The above analysis may also be of interest in
49
50 capillary flow under micro-gravity conditions as it may help explain the different regimes of
51
52 flow reported in the literature^{30,31}.

4.6. Tilted tubes and the effective capillary length

The capillary length characterizing the balance between surface tension and gravitational forces is given by $\kappa^{-1}=(\gamma_{LV}/\rho g)^{1/2}$. Using the gravitational force along the tube for an inclined tube gives

$$\kappa^{-1}(\varphi)=\sqrt{\frac{\gamma_{LV}}{\rho g \sin \varphi}}. \quad (21)$$

As the angle φ decreases, the capillary length $\kappa^{-1}(\varphi)$ increases which in turn means that the ratio of the radius over the capillary length decreases. For our vertically oriented tubes of radii 140 μm to 675 μm the ratio of radius to capillary length is $R/\kappa^{-1}(90^\circ)=0.095$ to 0.458, whereas for the two tilted tubes of radii 190 μm and 650 μm , the ratios are $0.129\sin^{1/2}\varphi$ and $0.442\sin^{1/2}\varphi$. For the lowest tilt angle of 5° these give 0.038 and 0.13, respectively.

Imbibition in tilted tubes was also found to be slower than predicted and an increase in effective viscosity of $a_{scaling}=(\eta/\rho)_{scaling}$ was also needed to fit the data, and that, for a given viscosity and tube radius ($R=190 \mu\text{m}$ or $650 \mu\text{m}$), $(\eta/\rho)_{scaling}$ reduces with reducing tilt angle φ . This suggests that the effect of tube radius reduces with decreasing gravitational force (*via* decreasing tilt angles) which appears to relate to the effective value of $R/\kappa^{-1}(\varphi)$. Fig. 9 shows that $(\eta/\rho)_{scaling}$ increases with $R/\kappa^{-1}(\varphi)$, with good agreement between theory and experiment for values of $R/\kappa^{-1}(\varphi)<0.1$, and that the trend is consistent with the results in vertical tubes discussed above (also included in fig. 9 for comparison). These observations show that the effect of the radius becomes less of an issue in horizontal capillaries and micro-channels, and may, therefore, have important implications in our understanding of the dynamics of flow in such systems. It would be very interesting to repeat the measurements with different liquids to establish whether

3 the trend observed in fig. 9 holds, and whether the magnitude of the viscosity scaling factor
4
5 $a_{scaling}$ is also dependent on the liquid-solid interface as suggested in some reports in the
6
7 literature^{28,32}.

10 11 5. CONCLUSIONS 12 13

14
15 In this work, we have presented a systematic study of the dynamics of capillary penetration of
16
17 PDMS oils in vertical and tilted glass tubes at a range of angles of inclination to the horizontal, φ
18
19 ($10^\circ \leq \varphi \leq 90^\circ$). The penetration length versus time data were fitted using the exact numerical
20
21 solution and the approximate analytical visco-gravitational and Bosanquet solutions using a
22
23 constant contact angle. We found the visco-gravitational solution to be the most appropriate
24
25 analytical approximation to the exact solution even for lower inclinations (around 10°) when one
26
27 might expect the Bosanquet solution to be the best approximation for most of the range. This
28
29 indicates that gravity may need to be taken into consideration in any quantitative analysis of rate
30
31 of imbibition, especially in micro and nano-sized channels. From the fits, we found that the
32
33 theory agrees with experiment in small tube radii, R , when $R/\kappa^{-1}(\varphi) < 0.1$, where
34
35 $\kappa^{-1}(\varphi) = \sqrt{\gamma_{LV}/\rho g \sin \varphi}$ is an effective capillary length which uses the component of
36
37 acceleration due to gravity along the axis of the tube, $g \sin \varphi$. For tubes of larger radii that satisfy
38
39 $R/\kappa^{-1}(\varphi) > 0.1$, the flow is found to be slower than predicted and showing an increase with R/κ^{-1}
40
41 (φ) for all tubes and tilt angles. Moreover, at fixed radii, we observed, for the first time, that
42
43 effect of the tube radius becomes less of an issue when the gravitational force is reduced at lower
44
45 tilt angles.
46

3 We also showed that by non-dimensional rescaling and re-plotting the imbibition data, it is, in
4 principle, possible to separate the different regimes of flow. The re-scaling also enabled us to
5 develop a new experimental method that allows the determination of the dynamic contact angle
6 $\theta(t)$ during imbibition. An excellent agreement was obtained between our values of $\theta(t)$ and
7 those given by a recent empirical formula suggested by Heshmati and Piri²⁵. Our analysis found
8 the dynamic contact angle to play an important role at the early stages of imbibition, in
9 agreement with other reports in the literature, but that the use of a constant contact angle was still
10 adequate to fit the dynamic data for the later stages. This indicates that the dynamic contact angle
11 cannot solely account for the slower rise than anticipated in the wider tubes. Further
12 measurements will be needed to validate the method further using different channel geometries,
13 liquids and capillaries.

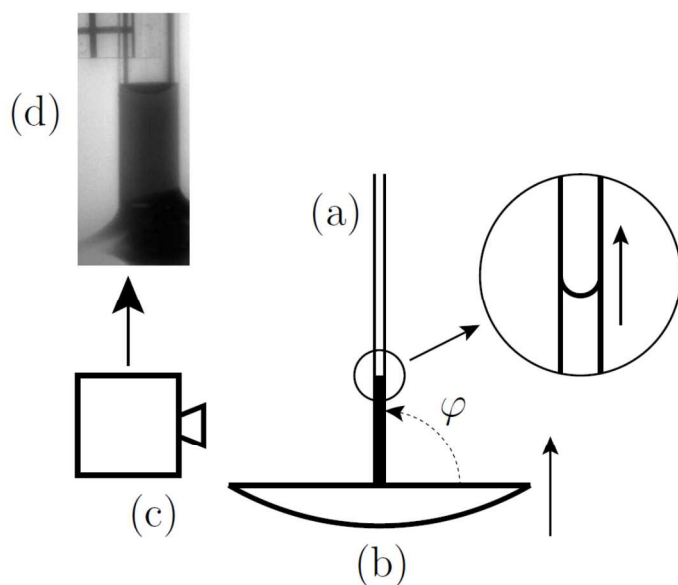


Figure 1: A schematic of the experimental set up showing the glass capillary tube (a) tilted at an angle φ ($5^\circ \leq \varphi \leq 90^\circ$). The liquid in the reservoir (b) was slowly brought up (shown by vertical arrows) until spontaneous filling starts. Recording was made with the CCD camera (c) which is oriented at the same angle φ as the sample so that the tube remained vertical to the field of view of the camera, as shown in (d). The evolution of the penetration length along the tubes is recorded as a function of time.

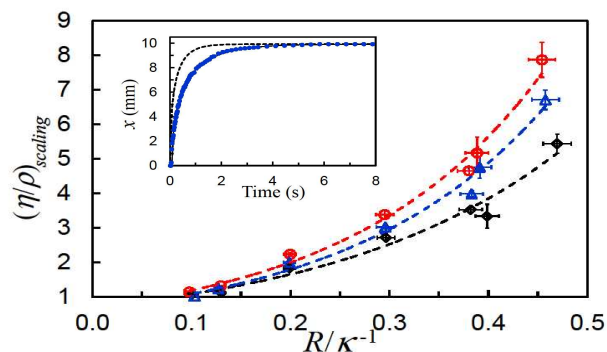


Figure 2. Scaling factors required to fit the data for capillary rise of PDMS oils of viscosities 9.6 mPas ($\diamond\diamond\diamond$), 19.2 mPas ($\circ\circ\circ$) and 48 mPas ($\triangle\triangle\triangle$) inside vertical glass tubes. The dashed lines are to guide the eye for the trend with the ratio of radius to capillary length, R/κ^{-1} . Inset: Capillary rise of 9.6 mPas PDMS oil inside a tube of radius $R=430\ \mu\text{m}$. Solid circles are data points, dashed curve is the numerical solution of eq. (1) using $\rho=913\ \text{kg m}^{-3}$, $\gamma_{LV}=19.8\ \text{mN m}^{-1}$, $\theta=0^\circ$, and solid curve through the data points is visco-gravitational solution with $\eta_{scaling}=2.628$. Both the dashed and solid curves use $(\gamma_{LV}/\rho)_{scaling}=0.965$ to match the observed equilibrium length. Larger versions of the graphs are shown in the supporting information.

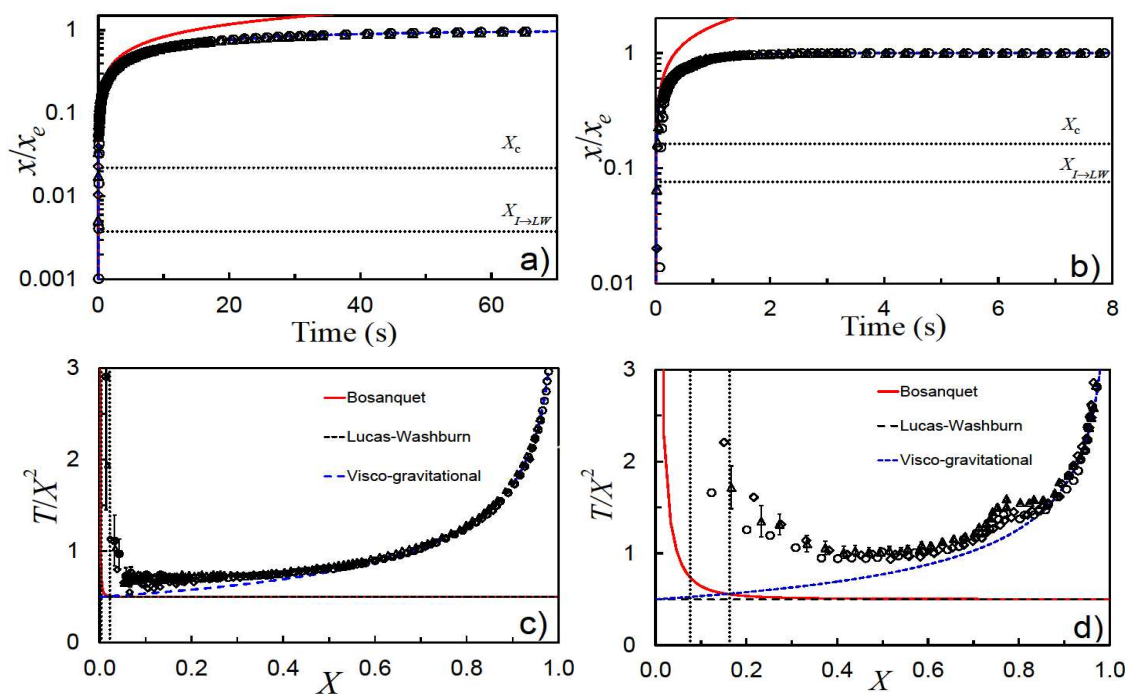


Figure 3. The rise dynamics in the form of a semi-log plot of $X=x/x_e$ as a function of time, t , for three data sets for a) $R=140 \mu\text{m}$ and $\eta=19.2 \text{ mPas}$, and b) $R=675 \mu\text{m}$ and $\eta=9.5 \text{ mPas}$. In each graph, the equilibrium lengths, x_e have been taken from the Mathematica fits. c) and d) are non-dimensional scaling and re-plotting of the data of a) and b) respectively in the form of T/X^2 with X , where $T=t/\tau$ (τ is a characteristic fitting time). In the graphs, the symbols represent the experimental data, the lines represent the Bosanquet solution, eq. (15) (—), the Lucas-Washburn solution, eq. (16) (---) and the visco-gravitational fits eq.17 (---). The dotted lines represent the cross-over penetration lengths X_{I-LW} (eq. (20)) and X_c (eq. (18)). In c) $\tau=29 \text{ s}$; $a=\tau g \sin \phi/x_e=9680 \text{ s}^{-1}$; $X_{I \rightarrow LW}=0.0038$ and $X_c=0.022$, and in d) $\tau=0.7 \text{ s}$; $a=\tau g \sin \phi/x_e=1045 \text{ s}^{-1}$; $X_{I \rightarrow LW}=0.074$ and $X_c=0.16$.

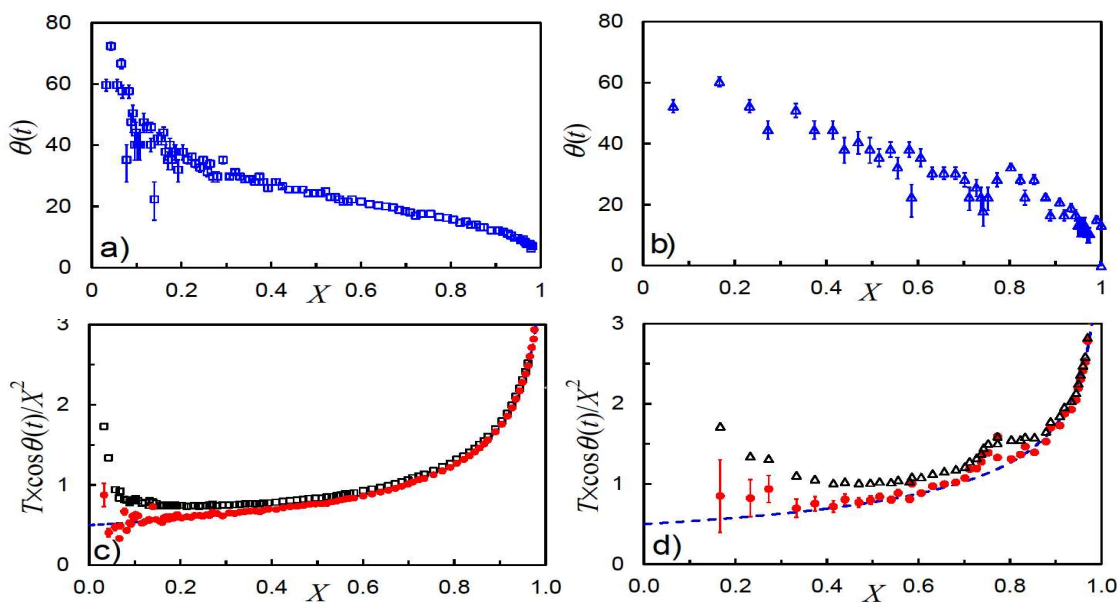


Figure 4: The effect of a dynamic contact angle $\theta(t)$. For each experimental data point in fig 3a and 3b, $\theta(t)$ was estimated using the Hoffman correlation²² and the corresponding variation of $\theta(t)$ with X are shown for a) $R=140 \mu\text{m}$ and $\eta=19.2 \text{ mPas}$, and b) $R=675 \mu\text{m}$ and $\eta=9.6 \text{ mPas}$. c) and d) show the effect of adjusting the scaled data of fig 3c and 3d respectively from T/X^2 (open symbols) to $T \times \cos \theta(t) / X^2$ (closed symbols). τ needed adjusting from 29 to 28 s⁻¹ in c), and from 0.70 to 0.68 s⁻¹ in d). A much improved agreement with the visco-gravitational solution (dashed line) is observed as result.

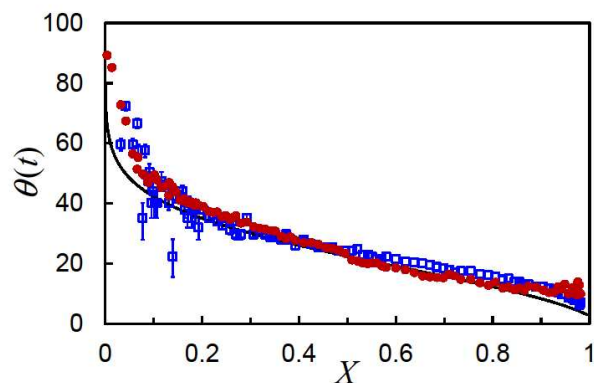


Figure 5: Variation of dynamic contact angle, $\theta(t)$, in a vertical tube $R=140 \mu\text{m}$, $\eta=19.2$ mPas (data of fig. 4a) estimated from: Hoffman empirical correlations ($\square\square\square$) (Hoffman²²) and from dividing the scaled experimental value T/X^2 (fig.3c) by the corresponding visco-gravitational solution using eq. (17) ($\bullet\bullet\bullet$). The data show good agreement with the empirical trend proposed by Heshmati and Piri²⁵ (solid line) using with their values of the parameters $A=1.03$, $B=-2.47$ and $C=27.7$.

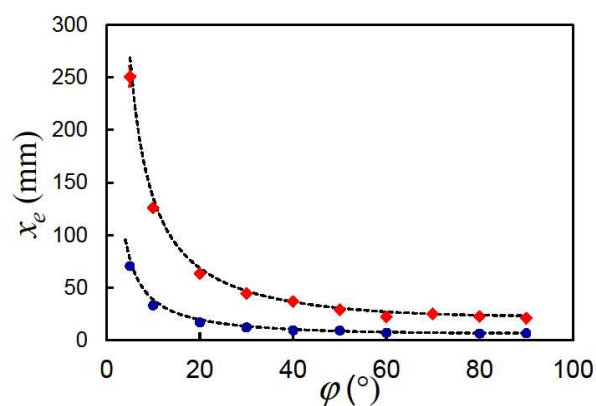


Figure 6: Dependence of equilibrium length of PDMS oils, x_e , on tilt angle, φ , in glass tubes of radii $R=650 \mu\text{m}$ ($\bullet\bullet\bullet$) and b) $R=190 \mu\text{m}$ ($\blacklozenge\blacklozenge\blacklozenge$). The dashed lines show the theoretical predictions for x_e determined using eq. (5).

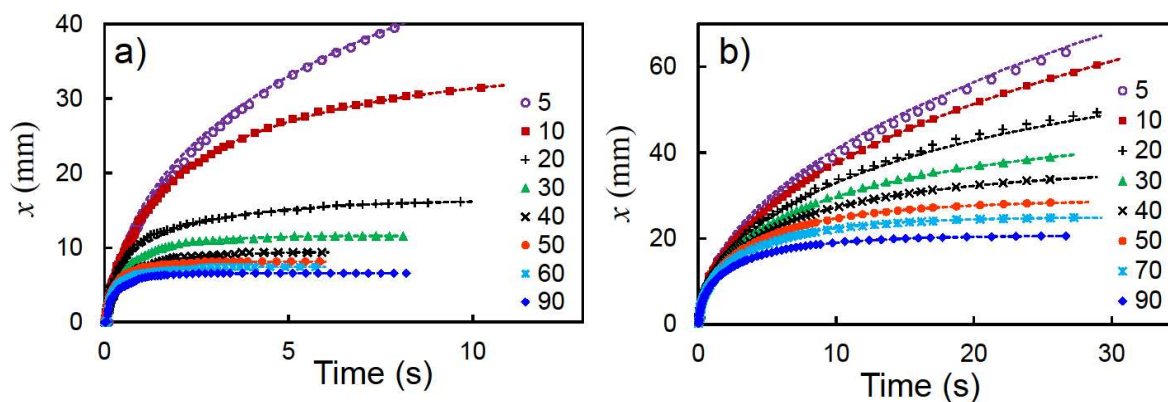


Figure 7: The effect of tilt angle, ϕ , on the dynamics of capillary penetration of 9.6 mPas PDMS oil in tubes with a) $R=650 \mu\text{m}$ and b) $R=190 \mu\text{m}$. The dashed lines are the corresponding visco-gravitational fits.

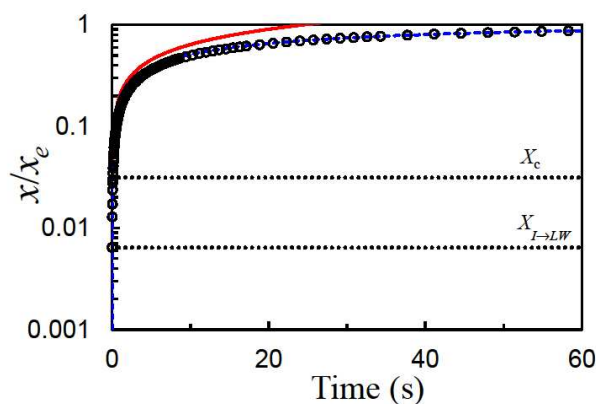


Figure 8. Capillary penetration of PDMS oil of viscosity $\eta=48 \text{ mPas}$ in a tube of radius $R=650 \mu\text{m}$ at $\phi=10^\circ$. The symbols represent the data points, and the solid and dashed lines represent the Bosanquet solution and visco-gravitational fits respectively. The dotted horizontal lines give cross-over lengths values $X_{I-LW}=0.006$ and $X_c=0.031$.

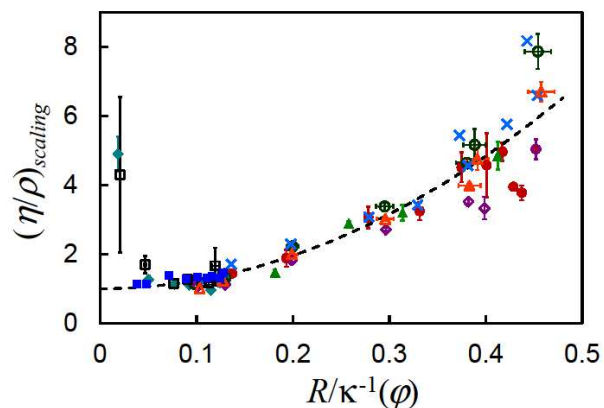


Figure 9: Dependence of the scaling factor $a_{\text{scaling}} = (\eta/\rho)_{\text{scaling}}$ on the effective $R/\kappa^{-1}(\varphi)$ ($5^\circ \leq \varphi \leq 90^\circ$) in tilted tubes with radius $R=190 \mu\text{m}$ ($\color{red}\blacklozenge\color{red}\blacklozenge\color{red}\blacklozenge$: $\eta=9.6 \text{ mPas}$, $\square\square\square$: $\eta=19.2 \text{ mPas}$, $\blacksquare\blacksquare\blacksquare$ $\eta=48.0 \text{ mPas}$) and $R=650 \mu\text{m}$ ($\color{red}\bullet\bullet\bullet$: $\eta=9.6 \text{ mPas}$, $\color{blue}\times\times\times$: $\eta=19.2 \text{ mPas}$, $\color{green}\blacktriangle\blacktriangle\blacktriangle$: $\eta=48.0 \text{ mPas}$). Also shown is the data from fig. 2 in vertical tubes for $\eta=9.6 \text{ mPas}$ ($\color{purple}\blacklozenge\blacklozenge\blacklozenge$), 19.2 mPas ($\bullet\bullet\bullet$) and 48.0 mPas ($\color{red}\blacktriangle\blacktriangle\blacktriangle$). The dashed line is a guide to the eye for the general trend.
