

In compiling the list for 2019, we noticed some other interesting stories.

A few companies in the list this year have post codes from Leicestershire and Derbyshire - despite being clearly located in Nottinghamshire. This is largely a result of the way post codes relate to centres from which postal services are organised.

In areas near county boundaries it is not unusual for postal services to be delivered from centres outside Nottinghamshire. This points to the way that administrative boundaries - like county boundaries - seldom constrain economic activity. These boundaries are essentially porous.

The local economy of Nottingham and Nottinghamshire is influenced to a significant

degree by centres located outside the county.

We see this very clearly in the influence of neighbouring cities such as Sheffield, Derby and Leicester.

From an economic development perspective, this also points to the importance of understanding the role that major cities like Nottingham play in the wider spatial economy of our region.

The Top 200 and Top 20 employers list both provide plenty of evidence of the role that Nottingham plays as a regional centre for the provision of business services, health and education.

The former is clear from the presence of companies like Experian, KPMG and Potter Clarkson in Nottingham, the latter from the prominence of Universities and NHS Trusts on our list of major local employers.

It also emphasises the role of these large organisations as anchor institutions that underpin the local economy - through the services they provide and the influence they exert in the local area.

Looking forward, it is very likely that organisations like these will have a key part to play, along side our local authorities, in supporting economic resilience as we face the challenges to come.
